2024 Reminder Personal Income Tax Returns

This document is a reminder to help you gather all your documents and provide us with all the relevant information to prepare your tax returns as well as those of your family.

We ask that you take the time to read it carefully and provide us, from the outset, with all the necessary documents and information for your file. This will allow us to be more efficient and reduce the preparation time of your tax returns and, consequently, your fees.

YOU DO NOT NEED TO PROVIDE US WITH THIS COMPLETED DOCUMENT

Instead, complete the "Required Form" and provide any relevant information in the "Comments" section of the form or in a separate document.

The questions included in the "Required Form" are not repeated in this document.

Refer to the "What's new for 2024" document to learn about new credits or changes that may apply to your situation.

TO HELP US

- Please wait until you have all your documents before sending them to us. Incomplete files force us to set your file aside, return to it later, and thus double the work and time we devote on it.
- Never send us documents in photo format. These documents present significant challenges and result in wasted time (they are often illegible and cannot be sorted in PDF format). There are smartphone apps available that can easily convert photos into PDF.
- As much as possible, provide us with everything either in paper format or electronic format (PDF), but not a combination of both.
- If you have fewer than 20 slips and are sending them to us in PDF format, please gather them into a single document except for medical expenses, which should be in a separate document.
- If you have 20 slips or more, group them by type of slip (e.g., donations, investment statements, medical expenses, other slips) before uploading them.
- Do not group documents for your personal tax returns with those of your company, if applicable. Send them in two separate envelopes or upload them separately on the respective portals.
- Please send your documents in a single upload, as we receive an email each time.
- · Avoid sending us duplicate documents.


